# Commercial Pilot with Applied Human Factors Aviation Diploma

## Overview

*An enhanced level of pilot decision-making and situational awareness relevant to entry level pilots into the aviation industry and instruction of trainee pilots.*

*The successful traits and skills required to pass the usual advanced pilot selection processes in aviation today, which are often based on a psychological examination or assessment procedure.*

*Methodological analysis, problem solving and evaluation, which are useful in dealing with abnormal and emergency scenarios that may be encountered in the aviation industry.*

*Obtain a Transport Canada Commercial Pilot licence, endorsed with an enhanced knowledge of human factors and mountain flying abilities.*

# Private Pilot Program

## Overview

To qualify as a Private Pilot, students must undergo two examinations—one is a flight test conducted in an aircraft with an examiner, and the other is a written examination conducted by Transport Canada.

There are time limits on when these examinations must occur—the flight test must be completed no later than two years after successfully completing the written examination, and the written examination, in turn, must be completed no later than one year after successfully completing the flight test. Private Pilot training is therefore oriented towards preparing students for these two examinations—that is, the flight training portion prepares students for the flight test, while the ground school portion prepares students for the written examination.

While flight training is conducted one-on-one with a Flight Instructor, ground school is normally conducted in a conventional classroom setting. All training must conform with standards established by Transport Canada, and the aircraft used for training must meet the maintenance standards established by Transport Canada for certified commercial aircraft.

# Commercial Pilot Program

## Overview

*Commercial Pilot Training is composed of ground school and flight training segments.*

*The ground school is designed to prepare students for the knowledge requirements for the Commercial Pilot Licence, as demonstrated on the Transport Canada written examination.*

*In contrast, the flight training segment is designed to prepare students for the skill requirements for the licence, as demonstrated on the Transport Canada Commercial Pilot flight test. In accordance with the International Civil Aviation Organization, all pilots must demonstrate English language proficiency.*

# Flight Instructor Rating

## Overview

Successful completion of the Instructor Rating Program leads to eligibility for Class IV Instructor Rating and the issuance of a Certificate of Qualification—Instructor Rating from Langley Flying School, Inc.

The holder of a Class IV Instructor Rating may exercise the privileges of a Flight Instructor in accordance with the Canadian Aviation Regulations.

# Multi-engine Class Rating Program

## Overview

The holder of a Multi-engine Class Rating may exercise the privileges of Pilot-in-command of multi-engine aircraft.

The Multi-engine Class Rating is recommended for Commercial Pilot students since passenger transport is conducted primarily in multi-engine aircraft. Multi-engine Class Rating is required for qualification for an Airline Transport Pilot Licence.

# Group 1 or 3 Instrument Rating Program

## Overview

The Multi-engine (Group 1) is recommended for Commercial Pilot students since passenger transport is conducted primarily in multi-engine aircraft.

The Group 1 Instrument Rating is required for qualification for an Airline Transport Pilot Licence.

# Night Rating Program

## Overview

Successful completion of the Night Rating Program leads to eligibility for Night Rating issued by Transport Canada, and the issuance of a Certificate of Qualification—Night Rating by Langley Flying School, Inc.

The holder of a licence endorsed with a Night Rating may exercise the privileges of the licence in Night VFR conditions. Credit for the Night Rating may be transferred to Commercial Pilot Program.
